## Annual Assessments

Annual assessments for each lot are \$50 due March 1st and cover the period from January 1 through December 31 of the current year.

Any past due assessment will be added.

Lot assessments pay for the following:

- Maintenance of O'Fallon Hills signage
- Lawn care/trash pickup at entrance
- Community information and notice sign
- Electricity and maintenance of street lighting
- Annual big trash pickup by Grace Hauling
- Clerical and postal fees for mailings
- Legal fees to pursue unpaid assessments
- Halloween & Christmas decoration awards
- Bookkeeping and clerical services
- Community Event

Delinquent accounts that are over \$150 on May 1, 2025, will be pursued by the community attorney and the resident will be responsible for all legal fees as well as delinquent balance.

If you have been contacted by the attorney, you will need to make your payment with the attorney via Cash or Money Order.

Please be aware that selling or refinancing your home will require all balances to be paid in full prior to closing. Unpaid delinquent accounts will result in a lien against the property.

## Online Bill Pay

If you would like to have your bank to send the check on your behalf, you can set us up as a payee. You simply log in to your bank account, go to your online bill pay system. Begin to add a new company.
