THIS INDENTURE made and entered into this 22 day of MARCH.

1983, by and between undersigned, parties of the First part hereinafter referred to as Grantors and Leo Guffey, William Woolever and William Wiegert, parties of the Second part hereinafter referred to as Trustees.

WITNESSETH THAT:

WHEREAS, the Grantors are the owners of certain tracts of land in St. Charles County, Missouri, which tracts are located in O'Fallon Hills, a subdivision recorded in Plat Book 6, page 82 of the St. Charles County, Missouri records; and


whereas, the Developers of said subdivision, being desirous of promoting and enhancing the value of said subdivision by stabilizing residential values and establishing facilities and services therein, did by an instrument recorded on July 17, 1959 in Book 330, page 277 and amendment thereto recorded on August 12, 1959 in Book 330, page 706, each recorded in the St. Charles County, Missouri records, did establish a trust of certain rights in and to said subdivision and set restrictions on the use of certain portions thereof; and

WHEREAS, undersigned desire to make certain that the benefits of the trust and the restrictions stabilize residential values and reflect the residential atmosphere and character of the neighborhood; and

WHEREAS, the Indenture and Amendment provide for a means of amending and modifying the restrictions; and

WHEREAS, the undersigned desire to amend the indenture and restrictions to redefine certain minimum square footage requirements and to further define residence; and

WHEREAS, the Trustees acquiesce in such changes and amendments and are willing to accept the duties, responsibilities and benefits herein conferred on them;

NOW, THEREFORE, the Grantors in consideration of the premises and covenants herein contained and of the sum of Ten Dollars (\$10.00) and other good and valuable considerations, the receipt of which is hereby acknowledged, and in consideration of the agreement and consent of the parties of the Second part, do hereby grant, bargain and sell, convey, transfer, assign and set over unto the said Trustees, their successors and assigns and do hereby change, modify and amend the Indenture recorded on July 17, 1959 in Book 330, page 277 and Amended Indenture recorded on August 12, 1959 in Book 330, page 706, in the St. Charles County, Missouri records and that it is agreed as follows, to-wit:

- 1. That Article III, Section 5 shall be amended, modified and changed to read as follows:
 - 5. No building or structure shall be erected, placed or altered on any lot in O'Fallon Hills until the building plans, specifications and plot plans showing the location of such building or structure have been approved in writing by the Trustees as to type of structure, square footage, general plan, external design, compliance with restrictions and as to location of the building or structure with respect to property and set back or side lines. Should the Trustees fail to approve or disapprove such building plans, specifications and plot plans within sixty (60) days after such plans have been submitted, or, in any event, if no suit to enjoin the erection of such building or structure, or the making of such alterations has been commenced prior to completion thereof, then such approval will not be required and the requirement herein set forth will be deemed to have been met.
- 2. That Article V, Section 1(a) shall be amended, modified and changed to read as follows:
 - l(a). No lot in any block shall be improved or occupied for other than private, single-family, residentail purposes; and no business of any kind shall be conducted on any lot.

- 3. That Article V, Section 1(e) shall be amended, modified and changed to read as follows:
 - 1(e). No dwelling shall be constructed on any lot with less than one thousand two hundred (1200) square feet of floor space, excepting porches and porticos.
- 4. That Article V, Section 1 shall be amended, modified and changed to include a new subsection (n) which shall read as follows:
 - l(n). Only permanent residences shall be constructed on any lot and no mobile home and/or modular unit shall be placed and/or constructed on any lot. Mobile home means a factory built structure or structures equipped with the necessary service connections and made so as to be readily movable as an unit or units on its or their own running gear and designed to be used as a dwelling unit or units with or without a permanent foundation. Modular unit means a factory fabricated transportable building unit designed to be used by itself or to be incorporated with similar units at a building site into a modular structure to be used by residential purposes. The intent of this section includes but is not limited to the fact that the flooring and subflooring systems shall be constructed on site at the lot.
- 5. It is further agreed that invalidation of any one of these covenant or any part or subpart thereof by judgment or court order shall in no way affect any other provision which shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto have amended the Indenture and Amendment regulating the use of private streets and easements in the Subdivision known as O'Fallon Hills and defining restrictions governing lots therein as executed, and as so amended have caused the same to be republished herewith.






